**Subject:** Criminal Charges and Restraining Order Request against Sean M. Boushie, University of Montana

I am writing to notify all authorities with the University of Montana, the Missoula Montana Police, the District Attorney, the U.S. Attorney, and the FBI that I am filing criminal charges against Sean M. Boushie for stalking, harassment, and the federal crime of perjury in filing false copyright/trademark complaints with YouTube.

I have been told that people suspect the University of Montana knows that Sean Boushie does this and pays him to do it. That's a pretty wild idea, but there is no logical explanation for how the university and law enforcement would ignore what this guy has done. I have made complaints previously, as have others.

I am filming a movie and preparing a weekly television show about government, judicial, and law enforcement corruption. I intend for this story to be in the movie and on the TV show. I would like to interview each of you.
