Date January 23 2013,

I, Crystal L. Cox, Upon Knowledge and Belief, make this statement under Oath, Sworn to be True to the best of my Knowledge.

In the Summer of 2009, Sean Boushie sent me a Death Threat from the eMail address CrystalCoxisABitch@Yahoo.com, Eureka Montana Officer Maury McKinney protected Sean Boushie, and refused to give documents of evidence to me, Crystal L. Cox, regarding the man who threatened me.

Officer Maury McKinney claimed to have sent all proof and information to County Attorney Bernie Cassidy in Libby, Lincoln County Montana, the County Seat where I lived, and Sean Boushie owned Property and a Home.

I, Crystal L. Cox hired an attorney to get this information and help me to prosecute Sean Boushie, the Attorney was Kai Groenke, Kalispell Montana. She suggested we sue Sean Boushie for Defamation, and that would turn up discovery. As Sean Boushie had hate blogs about me, one statement he made in particular on mass sites was that NAR, the National Association of Realtors had Fired Me, and this one detail, my Attorney said would proof he defamed me, as it was an important detail that I quit and left in good standing and had all the paperwork stating this. Sean Boushie's comments had discredited and lied about my Real Estate Brokerage and my Attorney felt this was the best place to begin, as it was the clearest to prove.

This Lawsuit / Legal action was blocked by Lincoln County Attorney Bernie Cassidy, under the reason that there were, allegedly, ongoing investigations, this was over 3 years ago now. I have all the paperwork, documents, filings, details in this regard. My Attorney, even though well paid, dropped the case.

Since this time Sean Boushie has started Hate Groups on Facebook, Craigslist, and other online groups to gather hates, to incite hate and threats against me, to ruin any business I do and to constantly taunt me and anyone who is connected to me directly, indirectly or in any way.

For over 3 years and still now daily, Sean Boushie threatens me on my blogs in comments by the name of John Smith and many other aliases, one is my own name Crystal Cox. He comments on my YouTube videos, blogs and in forums where anyone is discussing anything related to me or the stories I report on. Not just free speech comments, but actually inciting hating, ruining businesses and gathering haters, encouraging violence and further defamation and attacks.



Sean Boushie has many online activities he does in the name Crystal Cox, my name, such as Facebook Accounts, Google Accounts, Match.com Accounts, Blog Accounts, and more. Sean Boushie impersonates me, steals my identity, the FBI has been told over and over and does nothing to assist.

Sean Boushie started a match.com account in my name and "winked" at me, to taunt me.

Sean Boushie puts craigslist ads in any town he thinks I am in, or where I live, no matter where I move to, and tells people not to "date" with, meet me, do business with me and posts vile hate and flat out lies.

Sean Boushie constantly taunts me, harasses, and tries to intimidate me. Sean Boushie googles threats such as "crystal cox murdered" then clicks on my blog in order to my stat counter to pick it up.

I am an investigative journalist / investigative blogger, Online Media, Sean Boushie eMails every person he can, that I post a story in regard to, and he lies to them about me, and attempts to convince them to join him in hating me, taunting me, harassing and threatening me.

Sean Boushie taunts, threatens, defames, harasses and intimidates my whistle blowers, sources and attempt to silence them.

Sean Boushie has ruined my 12 year old Real Estate Brokerage, turned mass amounts of people against me with lies, defamation, and painting me in false light.

I am a 4th generation Montanan, I left Montana, left my home, my business, my life in order to get further away from Sean Boushie geographically as he constantly threatens me and brags about his guns and concealed carry permit. And he owns a home on acreage in my hometown of Eureka, Montana which he comes to often.

I, Crystal L. Cox, left Montana in the Fall of 2009 and did not post on Montana Corruption for over a year, Sean Boushie still taunted me, gathered haters, subscribed to every YouTube channel, comment hatefully on my blogs and videos, emailed anyone who ever wanted to work with me, and constantly posted ads in craigslist to warn people about doing business with me, which ruined my previously lucrative real estate career.





Sean Boushie has ruined my life, and has put me under constant duress.

Sean Boushie attacks anyone, even remotely connected to me and with an online news media as large as mine, the connections are endless, and his victims are mounting daily, and all with the backing and support of Montana Law Enforcement and the paycheck of the University of Montana where he is on my stat counter all day every day for over 3 years now. The University of Montana has knowingly protected Sean Boushie, and there seems to be a connection to Montana AG Steve Bullock and the Attorney General, as well as other factors that protect this man, Sean Boushie, at the University of Montana to watch all I post daily and to incite hate, defame, threaten, and attack.
