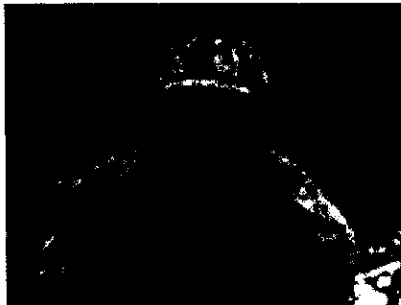

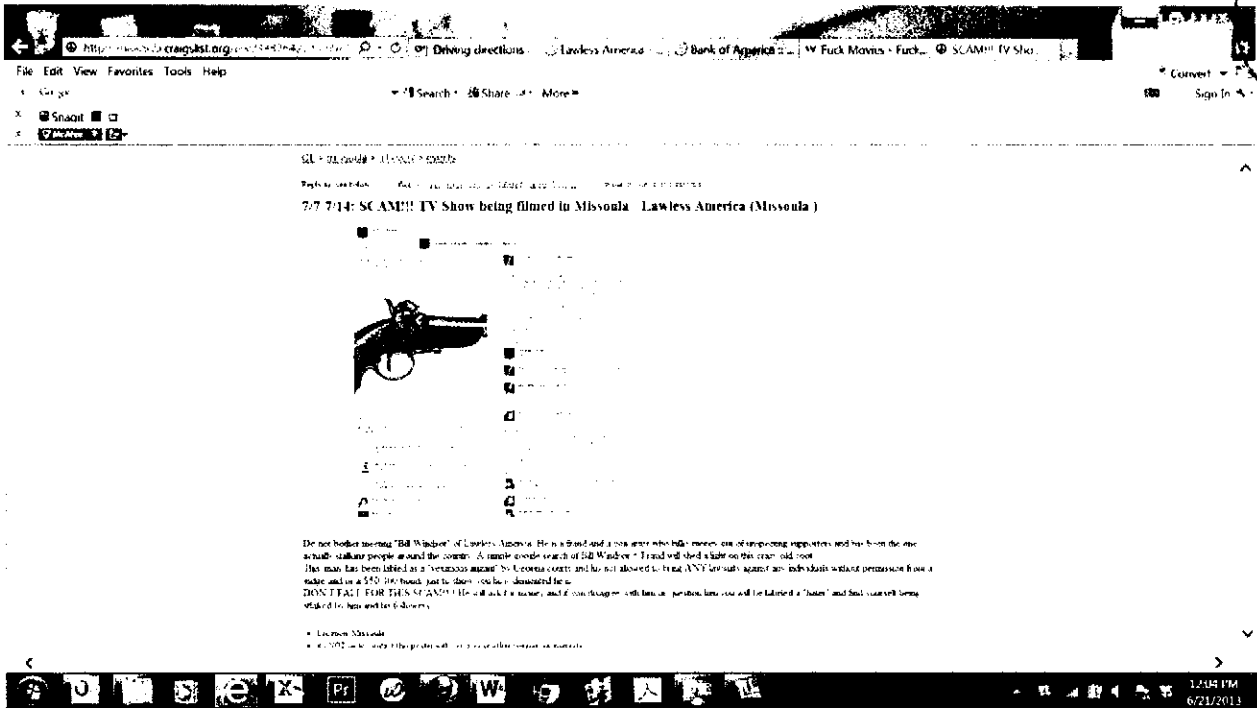

Bill Windsor is constantly seeking donations to fund this scam. He claims Lawless America is a 501 (c) 3 non-profit (which, by the way prohibits political activity, but this matters not to him), yet not a single state in the union seems to have a record of said non-profit.
