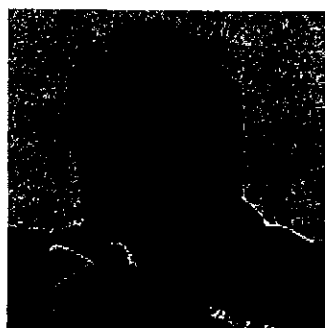

I know that Sean Boushie of the University of Montana uses a lot of aliases. May I ask that all of the email companies get together and figure out how to stop this guy. I have a dozen or so people who say they have been stalked and harassed by him. One woman says he threatened to kill her (crystal@crystalcox.com). One of the email addresses I believe he has used with me is gofuckyourself@yahoo.com.

We all know that crazy people can do crazy things. In my opinion, no sane person would do what this guy does. Sean Boushie indicates that he owns killing tools (guns and high-powered bows and arrows), and he has made numerous “veiled” threats against my life/health. I fear for my life. He has used a Glock and Charles Manson as his icons on Facebook when he stalks me there.
